

## REQUEST FORM – DATA SUBJECT ACCESS

### Your Subject Access Rights

You are entitled to know what information we hold, share, or use about you. In order to deal with your request, we may ask for proof of identity and enough information to enable us to locate the personal data that you request.

The purpose of this form is to ensure that all the necessary information to complete your request is provided to us. You are not obliged to use this form; however, if you do not, kindly ensure that all the necessary information on this form is otherwise provided to us. You will not usually need to pay a fee to access your personal data; however, if the subject *request is manifestly unfounded, excessive, or repetitive*, then we may either refuse to grant your request, by giving you a reason thereof, or charge a reasonable fee for complying with your request.

We will acknowledge safe receipt of your request and respond with the requested information within either one (1) month, or three (3) months, with an explanation on the reason why such extension is necessary, if the request is complex. In either case, we shall respond to your request within one (1) month.

To help us establish your identity, your application must be accompanied by two (2) pieces of identification which clearly show your name, date of birth, and current address. Kindly enclose certified copy of at least two (2) of the following as proof of identity:

- Passport;

- Driving license;
- Birth or adoption certificate;
- Bank statement (dated within the last three (3) months);
- Utility bill (dated within the last three (3) months).

This is to ensure that we are sending information only to the data subject and not to a third party. If none of these are available, please contact us for advice on other acceptable forms of identification.

To help us process your request quickly and efficiently, please provide as much detail as possible about the information you want. If possible, restrict your request to a particular service, department, teams, individuals, or incident.
